## Uniform Policy

## 1. Aims

This policy aims to:

- Set out our approach to requiring a uniform that is of reasonable cost and offers the best value for money for parents and carers
- Explain how we will avoid discrimination in line with our legal duties under the Equality Act 2010
- Clarify our expectations for school uniform


## 2. Our school's legal duties under the Equality Act 2010

The Equality Act 2010 prohibits discrimination against an individual based on the protected characteristics, which include sex, race, religion or belief, and gender reassignment. To avoid discrimination, our school will:

- Avoid listing uniform items based on sex, to give all pupils the opportunity to wear the uniform they feel most comfortable in or that most reflects their self-identified gender
- Make sure that our uniform costs the same for all pupils
- Allow all pupils to have long hair (though we reserve the right to ask for this to be tied back)
- Allow all pupils to style their hair in the way that is appropriate for school yet makes them feel most comfortable
- Allow pupils to wear headscarves and other religious or cultural symbols
- Allow for adaptations to our policy on the grounds of equality by asking pupils or their parents to get in touch with Miss Havard (Vice Principal), who can answer questions about the policy and respond to any requests


## 3. Limiting the cost of school uniform

Our school has a duty to make sure that the uniform we require is affordable, in line with statutory guidance from the Department for Education on the cost of school uniform. We understand that items with distinctive characteristics (such as branded items, or items that have to have a school logo or a unique fabric/colour/design) cannot be purchased from a wide range of retailers and that requiring many such items limits parents' ability to 'shop around' for a low price.

We will make sure our uniform:

- Is available at a reasonable cost
- Provides the best value for money for parents/carers

We will do this by:

- Carefully considering whether any items with distinctive characteristics are necessary
- Limiting items with distinctive characteristics to low-cost or long-lasting items, such as ties
- Considering cheaper alternatives to school-branded items, such as logos that can be ironed on, as long as this doesn't compromise quality and durability
- Avoiding specific requirements for items pupils could wear on non-school days, such as coats and bags.
- Keeping the number of optional branded items to a minimum, so that the school's uniform can act as a social leveller
- Avoiding different uniform requirements for different year groups
- Avoiding different uniform requirements for extra-curricular activities
- Making sure that arrangements are in place for parents to acquire second-hand uniform items
- Avoiding frequent changes to uniform specifications and minimising the financial impact on parents of any changes
- Consulting with parents and pupils on any proposed significant changes to the uniform policy moving forwards and carefully considering any complaints about the policy


## 4. Expectations for school uniform

### 4.1 Our school uniform

It is important to us that parents and pupils are clear that George Eliot Academy uniform is a requirement and that all pupils must meet these standards at all times.

The George Eliot Academy uniform consists of smart trousers, shirt, tie and blazer, and encourages students to take great pride in their appearance. Pupils are expected to adhere to our uniform policy at all times, which consists of the following items:

| Sports socks | Compulsory |
| School rugby top—black and green | Optional |
| Trainers | Compulsory |
| Football Boots | Optional |

## Coats, bags and accessories

| Coat-Plain, full length coat or anorak |

| School Bag-Must be big enough for the A4 knowledge pack. No Handbags are allowed |
| Jewellery-A watch, school badges and one small pair of plain ear studs may be worn |
| Hairstyles-Must be simple and only natural colours, no extreme hair Styles, no patterns or <br> shapes cut into it |
| Hats - A plain black baseball hat in summer and a plain black woolly hat in the winter |
| Make up - Pupils can wear discrete natural makeup |

## Uniform guidelines

If pupils arrive to school in incorrect uniform, they will be isolated and expected to remote into lessons.

## Trousers

- No skinny fit trousers, jeans or leggings
- Black tailored trousers, no skin tight material.
- Trousers should be smart and business like

Black Tailored shorts (Knee Length)


School shoes
No trainers, pumps, high heels or canvas shoes

- Plain black
- Flat heeled
- Leather or leather look
- Boots can be worn under trousers

- Sports polo top-black and green with the school logo
- Shorts - Plain Black, Track Pants - plain black or Sports leggings - plain black (No cotton leggings)
- School hooded sports top - black and green with school logo
- No converse or fashion shoe to be worn


Nail Guidelines

- No nail varnish
- No excessive and impractical length nails
- No acrylic nails are permitted


Hair Guidelines

- Must be simple and only natural colours
- No extreme hair styles
- No patterns or shapes cut into it



## Coats, bags and accessories

- School bag must be big enough for A4 books to be carried



## Examples of non-permitted items

- Any non-permitted items will be removed to be collected at the end of the day
- We will seek support to correct any incorrect uniform

## 5. Expectations for our school community

### 5.1 Pupils

Pupils are expected to wear the correct uniform at all times (other than specified non-school uniform days) while:

- On the school premises
- Travelling to and from school
- At out-of-school events or on trips that are organised by the school, or where they are representing the school (if required)

Pupils are also expected to contact Miss Havard (Vice Principal) if they want to request an amendment to the uniform policy in relation to their protected characteristics.

### 5.2 Parents and carers

Parents and carers are expected to make sure their child has the correct uniform and PE kit, and that every item is:

- Clean
- Clearly labelled with the child's name
- In good condition

Parents are expected to lodge any complaints or objections relating to the school uniform in a timely and reasonable manner.

Disputes about the cost of the school uniform will be:

- Resolved locally
- Dealt with in accordance with our school's complaints policy

The school will work closely with parents to arrive at a mutually acceptable outcome.

### 5.3 Staff

Staff will closely monitor pupils to make sure they are in correct uniform. They will give any pupils and families breaching the uniform policy the opportunity to comply, but will follow up with the Principal if the situation doesn't improve.

Ongoing breaches of our uniform policy will be dealt with in line with our behaviour policy.

In cases where it is suspected that financial hardship has resulted in a pupil not complying with this uniform policy, staff will take a mindful and considerate approach to resolving the situation.

### 5.4 Governors

The governing board will review this policy and make sure that it:

- Is appropriate for our school's context
- Is implemented fairly across the school
- Takes into account the views of parents and pupils
- Offers a uniform that is appropriate, practical and safe for all pupils

The board will also make sure that the school's uniform supplier arrangements give the highest priority to cost and value for money, for example by avoiding single supplier contracts and by re-tendering contracts at least every 5 years.

## 6. Monitoring arrangements

This policy will be reviewed annually. At every review, it will be approved by Local Governing Body.

## What happens if my child comes to school without school shoes?

If there is a genuine reason for your child not wearing school shoes, we ask that you inform their form tutor or pastoral leader by email or telephone before your child arrives at school on that day. If no reason is provided your child will be isolated until this is corrected.

## What happens if my child comes to school without a compulsory item?

If there is a genuine reason for your child not wearing a compulsory item, we ask that you inform their form tutor or pastoral leader by email or telephone before your child arrives at school on that day. If no reason is provided your child will be isolated until this is corrected.

## What happens if I can't afford to replace school uniform?

If you cannot afford to replace the school uniform, please contact your child's form tutor or pastoral leader by email or telephone. We can point you in the right direction to gain support with this

## Why can't my child wear clothes, jewellery or make-up to express their personality and individuality?

School is a formal setting (just like a place of work or business) where pupils should be treated equally and have equal access to attention and support from staff. We do not want to encourage an environment where pupils are competing in terms of their appearance or how "fashionable" they look. Pupils very often claim that their appearance sets them apart from others and is an expression of individuality when actually they are simply conforming to the expectations of their peer group.

## Why can't my child wear piercings/nail extensions/varnish when I have been told that other children do?

Pupils often use this as their first defence with parents/carers and members of staff. Invariably, the truth is that everyone else is not being allowed to break the rules that also apply to your child. Where there are pupils wearing piercings/nail varnish/extensions then they will also be isolated until this is corrected.

## Why can't my child have nail extensions?

As previously stated, long nail extensions pose a risk when a pupil is engaged in physical activity or taking part in specific subjects within the curriculum. If one is ripped off or brushes another pupil, this can result in painful cuts and rips to the skin. In addition, the academy does not want to encourage an environment where such "additions" to appearances are taken as the norm.
